1724¹-1797

1743 Will of Richard Brizendine

South Farnham Parish, Essex County, Virginia

Dated 15 January 1743, the will of a **Richard Brizendine**, planter, names wife, **Elizabeth**, and sons **Isaac, John** and **Francis** and bequeaths “after her [his wife’s] death” enslaved woman, **Nell**, to son Isaac. He names his wife Executrix and the will was witnessed by **Benjamin Fischer, William Harner** and **Charles Dobyns**. The will was proven on 17 April 1744. Elizabeth signed with her mark.²

The three page inventory of the estate was entered on 15 May 1744 which Elizabeth signed with her mark.³

While **Nell** was a common name, and she would be 40 years older, this could possibly be the same Nell that is named in **Isaac Brizendine’s** 1783 and 1784 taxes.

1745 Purchase at Estate Sale

Essex County, Virginia

Isaac Brizendine made a purchase at the estate sale of **Thomas Smith**, which took place 18 Oct - 7 Nov 1745.⁴ [*Issac would presumably need to be at least 21; estimated date of birth 1724.*]

1745 Birth of Son, William

Essex County, Virginia

Issac’s son, William, born in Essex County, Virginia.⁵

1746 Lunenburg County, Virginia was established from **Brunswick County**.⁶

- 1764 **Charlotte County, Virginia** was created from part of **Lunenburg County**.⁷
- 1768 **Property**
Lunenburg County, Virginia
Drury Allen of Granville County, North Carolina sold **Isaac Brizendine** 300 acres on the head branches of **Couches & Tucking Creeks** on 7 March 1768; bounded by property of **Briggs, Stevenson, Curtis Call, Murrell & Bragg**.⁸
- 1768 **Processioner's Returns**
Lunenburg County, Virginia
Isaac's property boundaries were processioned on 30 March 1768 by **Zachary Estes** and **Coldwell Petty Poole**. His property was bounded by **John Baugh, William Cureton, William Murrell** and **Curtis Keats**. Isaac witnessed the procession of the boundaries of "...Murrell and Isaac Brizendine, Keats and Brizendine, Cureton and Brizendine, **John Stone** and **Peter Jones**."⁹
- 1768 **Property**
Lunenburg County, Virginia
William Jeter sold **Isaac Brizendine** 200 acres bounded by property of **Stevenson, Nicholas Edmunds, Thomas Dupree** and **Couches Creek** on 10 December 1768.¹⁰
- 1770 **Lawsuit**
Lunenburg County, Virginia
James Johnson came to court as a witness for **Isaac Brizendine** in a case against **Richard May**.¹¹
- 1772 **Surveyor of Roads**
Lunenburg County, Virginia

Isaac Brizendine appointed **Surveyor of Road** “from the Court House to where **Joseph Billups** is appointed.”¹²

1772

Processioner’s Returns

Lunenburg County, Virginia

A return of **James Easthem** and **John Glenn** of 27 March 1772 mentions just the surname Brisindine in examining the lines between “**Brisindine** and **Edmonds**” and between “**Dupree** and **Brisindine**.” Present at the processioning of the Brisindine/Edmonds line was **William Jeter, Sr.**¹³ The deed dated 10 December 1768 between William Jeter and Isaac Bizendine also mentions Dupree and Edmunds and supports that this surname mention is referring to Isaac Brizendine.

1779

Lawsuit

Lunenburg County, Virginia

Isaac Brizendine, plaintiff against **William Cooper** “same as last time at defendants cost.”¹⁴

1780

Grand Jury Member

Lunenburg County, Virginia

Isaac Brizendine member of Grand Jury at Hungary Town in Lunenburg in case of Andrew Johnson “and another” against John Patterson.¹⁵

1782

Personal Property Tax

Lunenburg County, Virginia

Isaac Brizendine was taxed for two white males over 16, ten enslaved people, seven horses and 23 cattle.¹⁶

1783

Personal Property Tax

Lunenburg County, Virginia

Isaac Brizendine is taxed for son, **Leroy Brizendine**, and enslaved people: **James, Nell, Winnie, Bob** and six unnamed “young” people as well as four horses and 16 cattle.¹⁷

Lunenburg County, Virginia
Isaac Brizendine is taxed for son, **Richard Brizendine**, and enslaved people **James, Nell, Winnie, Harry, Bob, Phill, Peter, Edeth, Jude, Dolce** and **Cloe** as well as four horses and 15 cattle.¹⁸
- 1785 **Personal Property Tax**
Lunenburg County, Virginia
Isaac Brizendine was taxed for one white male over 16, nine enslaved people, three horses and 13 cattle.¹⁹
- 1786 **Personal Property Tax**
Lunenburg County, Virginia
Isaac Brizendine was taxed for one white males over 16, nine enslaved people, four horses and 13 cattle.²⁰
- 1787 **Personal Property Tax**

On 2 May 1788, **Isaac Brizendine** was taxed for three white males over 16, six enslaved people over 16, five enslaved people over 12 and thirteen horses.²¹

On 1 May 1789, **Isaac Brizendine** taxed for two white males over 16, 3 enslaved people over 16, two enslaved people over 12 and three horses.²³

1790

On 4 May 1790, **Isaac** was taxed for three white males over 16, four enslaved people over 16, two enslaved people over 12 and five horses.²⁴

1791

Charlotte County, Virginia

On 4 April 1791, **Isaac** was taxed for 4 white males over 16, 4 enslaved people over 16, 1 enslaved person over 12 and 7 horses.²⁵

Charlotte County, Virginia

On 17 Mar 1792, **Isaac** was taxed for 5 white males over 16, 4 enslaved people over 16, 1 enslaved person over 12 and 7 horses.²⁶

1793

Property

Lunenburg and Charlotte County, Virginia

Isaac Brizendine & **Anne** his wife, of Charlotte County, on 2 January 1793 to **Lewelling Tucker** of Lunenburg, 182 acres on the **branches of Couches Creek** joining lands of **Joseph Smith, Thomas Dupree** [*father-in-law of Isaac's son William*], **Joseph Smith, John Edmunds, James Cooper** and **Thomas Stevenson**. Issac and Anne sign with their marks. Witnessed by **Richard Brizendine** [*son*], **Thomas Tisdale** and **William Tisdale** [*son-in-law*].²⁷

On 16 Mar 1793, **Isaac** was taxed for 4 white males over 16, 4 enslaved people over 16, 1 enslaved person over 12 and 10 horses.²⁸

1794 **Personal Property Tax**

On 28 Mar 1794, **Isaac** was taxed for 4 white males over 16, 5 enslaved people over 16, 1 enslaved person over 12 and 7 horses.²⁹

On 4 May 1795, **Isaac** was taxed for 4 white males over 16, 6 enslaved people over 16 and 8 horses.³⁰

On 29 March 1796, **Isaac** was taxed for 4 white males over 16, 5 enslaved people over 16 and 6 horses.³¹

1797 **Personal Property Tax**

On 23 March 1797, **Isaac** was taxed for 1 white male over 16, 2 enslaved people over 16 and 2 horses.³²

Post-Death

1797 **Inventory of Estate**

Charlotte County, Virginia

Isaac Brizendine died intestate. Inventory of estate taken on 17 Aug 1797. Enslaved people named in inventory: **Bob, Phill, Edy** and son **Adam, Surrey, Christian, Patt, Asa, George** (little), **Jude, Carney, Winney** and **George. William**

1798

Mention of Property

Charlotte County, Virginia

In a deed between **Phillip Bond** and **William Collier** on 2 January 1798 for property on Sandy Creek, Isaac's property is mentioned: "bounded by **Matthew Hutcherson, Miles Bottoms, Isaac Brizendine dec'd, James Markham & Chasteen Cock dec'd**." ³⁴

1798

Personal Property Tax

Charlotte County, Virginia

On 4 April 1798, **Isaac's estate** was taxed for no white males over 16, 2 enslaved people over 16 and two horses.³⁵

1799

Marriage of Daughter

Charlotte County, Virginia

On 6 January 1798, **Elizabeth Brizendine**, "dau. **Isaac Brizendine**" married **John Ford**. The wedding was performed by **Rev. Edward Almond**, surety for the bond was **Josiah Stokes**.³⁶

1798

Guardian Appointed for Orphans

Charlotte County, Virginia

Two sequential entries in Order Book for **Nancy** and **Young Brizendine** both described as "**orphan of Isaac**." They chose **William Tisdale** [*their brother-in-law*] as their guardian on 5 Nov 1798.³⁷

Account of Estate

Account of the estate of **Isaac Brizendine** entered into record on 12 Dec 1798.³⁸

1799

Marriage of Daughter

Charlotte County, Virginia

Susannah Brizendine, “dau. **Isaac** and **Anne Brizendine**,” married **George Petty** on 23 December 1799. Joshua Brizendine was surety.³⁹

1800

Taxes

Charlotte County, Virginia

Isaac [or likely his estate] was taxed for 1 white male, 1 horse and 1 enslaved person. Other Brizendines also taxed: **Richard, Isaac Jr., William** and **William, Jr.**⁴⁰ [The Virginia Genealogist, Vol. 15, p 110]

1800

Debt Due

Lunenburg County, Virginia

Debts due to **Alexander Spier, John Bowman & Co. Store, Cumberland Parish, Lunenburg County**. Isaac named with notation: “Moved several years past to Charlotte County, where he died. Son, **Wm. Brizendine**, his Executor, now lives in Charlotte County.”⁴¹ [Date estimated. No date given in this transcription.]

1802

Marriage of Son

Charlotte County, Virginia

John Brizendine married **Dacey Hall** on 22 December 1802. **Miles Bottom** was surety on bond.⁴²

1803

Marriage of Son

Charlotte County, Virginia

Young Brizendine married **Anne Ritter Herndon**, daughter of **Joseph Herndon**, on 9 November 1803. **Richard Brizendine** was surety on bond.⁴³

- 1804 **Marriage of Daughter**
Charlotte County, Virginia
Nancy Brizendine married **George Redmon** [*sic*] on 8 November 1804. **Benjamin Laine** was surety.⁴⁴
- 1810 **Personal Property Taxes**
Charlotte County, Virginia
Wife, **Ann**, taxed on four enslaved people.⁴⁵ Other Brizendines recorded in Charlotte County: **Young, James, John, Phillip, Quincy** and **Reubin Brizendine**.⁴⁶
- 1818 **Account of Estate of Ann Brizendine**
Charlotte County, Virginia
Ann died intestate and the account of her estate began in 1818, no specific date was given.
John Brizendine was the administrator of the estate.⁴⁷
- 1820 **Inventory & Sale of Ann Brizendine**
Charlotte County, Virginia
Inventory was taken by **Jonathan Ashworth, Jno Booth** and **L.A. Bacon** in October of 1820, no day given. Sale was entered on 6 August 1821.⁴⁸
- 1826 **Chancery Suit**
Charlotte County, Virginia
Leroy Brizendine and his surviving siblings and their spouses bring a suit against their brother, **William Brizendine**, “the administrator of the estate of Isaac Brizendine who died intestate” sometime before 17 August 1797 when the inventory of Isaac’s estate was entered. The suit was initiated on 6 November 1820 after Isaac’s wife Ann had passed away. The suit centers around a disagreement over two enslaved people, **Winney** and **George**, who were part of Ann’s dower.

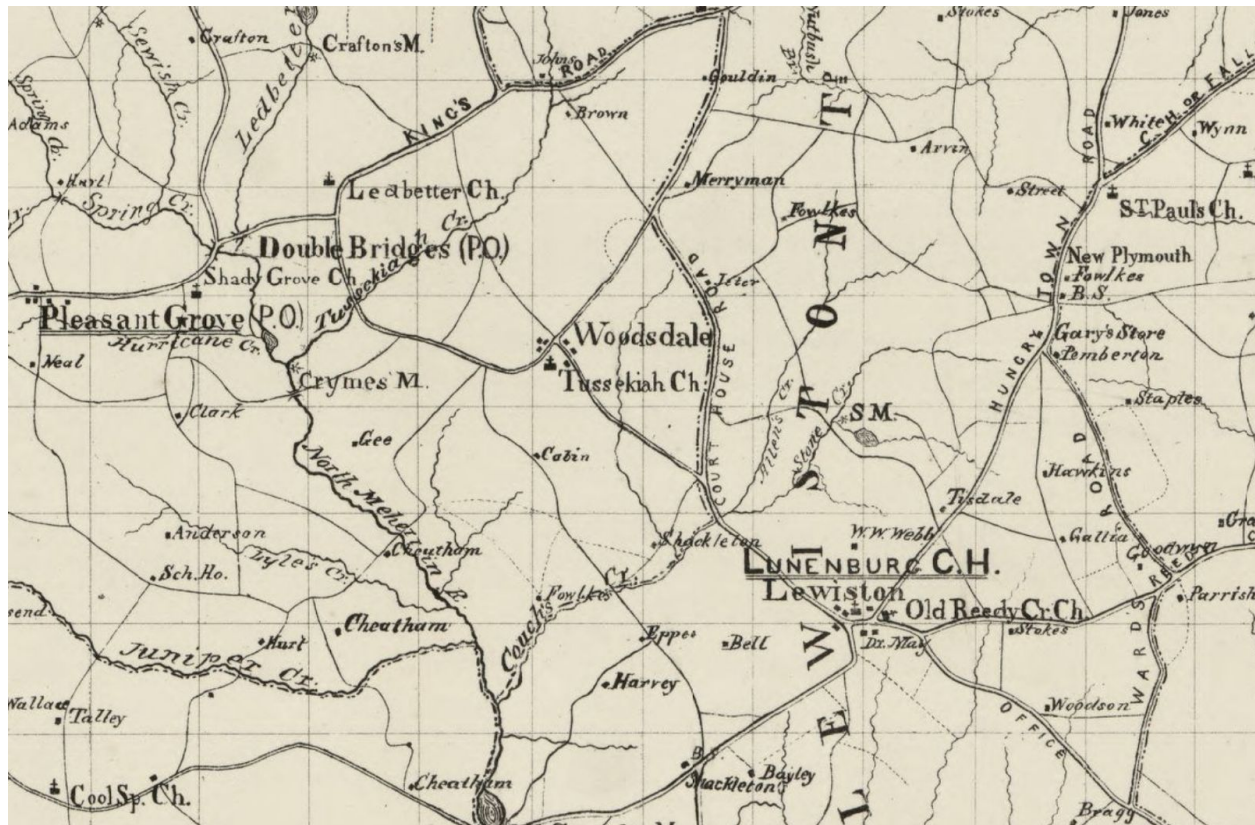

The children named in the suit were: **Richard, Leroy, John, Joshua, Nancy Redmond (George Redmond), Elizabeth Ford (John Ford), Susan Petty (George Petty), Phoebe Haines, Young, Jane Tisdale (William Tisdale) and William.** The suit also mentions Joshua’s “only daughter” **Jane.** Some of the language in the suit implies that Ann is the mother of all of the children: “...to have a sale of their mothers Dower slaves.”⁴⁹

The age span of the children [*William, born 1745 and Young and Nancy, born 1777 or later, based on guardianship in 1798*] seems to indicate that they are not all the biological children of Ann, who was also called Nancy, a common nickname for Ann, in some documents. Even if Nancy had been 16 in 1745, she would have been at least 48 in 1777, and even older if Young and Nancy were younger than 21 [*likely*] in 1798.
